CSE has developed Practitioner's Guides on key thematic areas namely - Water Sensitive Urban Design and Planning (WSUDP), Green Infrastructure, Septage Management (including wastewater), Urban Water Efficiency and Conservation as well as template on Urban Water Sustainability to help cities design and implement water - river sensitive strategies. The centre is assisting Ministry of Housing and Urban Affairs and National Mission Clean Ganga as recognised training entity for capacity building of state / city officials and others (private consultants, NGOs, and other agencies / institutions) supporting cities.

NIUA in partnership with NMCG has recently launched River City Alliance - a collaborative platform to discuss and exchange information on aspects that are vital for sustainable management of urban rivers and waterbodies. This Alliance will focus on three broad themes - Networking. Capacity Building and Technical Support. This training cum workshop is being organised by CSE SWW in partnership with National Institute of Urban Affairs (NIUA) and is supported by National Mission Clean Ganga.

The training cum workshop will help cities to identify, design and implement appropriate interventions best suited to respective cities at various scales that can be incorporated in Master Plans (including Development Plans/Zonal Plan, Area Development Plan cum Infrastructure Development schemes) or the Citywide Water – Sanitation Plans to be prepared by each local body under various national urban missions - namely AMRUT 2.0, SBM 2.0 and others.

AIM

Capacity building aimed to help cities develop implementable action plan for mainstreaming river and water centric planning and development.

TARGET AUDIENCE

- State / City Municipal functionaries (including **Development Authorities, Town & Country Planning** Department, PMU functionaries including regulators /
- Private consultants, NGOs, Planning & Architecture College/universities and officials from other institutions supporting cities in preparing Master Plan / Regional Plans, City Water and Sanitation Plans, Infrastructure Plans, Local Area Plans, Area Development and Township development projects.

- Prepare implementable action plan for integrating elements of WSUDP and river thinking into existing or upcoming Master Plans / Zonal Plans / Local Area Plans and Development Plans for infrastructure / townships development projects
- Develop strategies for stakeholder engagement and community participation
- Interact and learn from real implementers and beneficiaries of successfully implemented WSUDP interventions
