Introduction to AMRUT MITRA

- AMRUT Mitra is a convergence initiative under AMRUT 2.0 and DAY-NULM, focusing on SHG women's participation in urban water infrastructure.
- Theme - Women for Water, Water for Women
- Initiated in February, 2024 launched in March, 2024 by AMRUT, Ministry of Housing and Urban Affairs
- Aims to increase the involvement of women Self-Help Groups (SHGs) in different aspects of urban sanitation.

Uttar Pradesh like other states initiated the AMRUT Mitra model, integrating SHGs into urban sanitation projects with a structured engagement approach:

- Implementation in Four Cities: Sitapur, Khurja, Raebareli, and Jaunpur.
- Project Scale: 89 projects executed, engaging 884 women in sanitation efforts.
- FSTP Operations: Four projects dedicated to FSTPs, with 16 women enrolled for O&M activities.

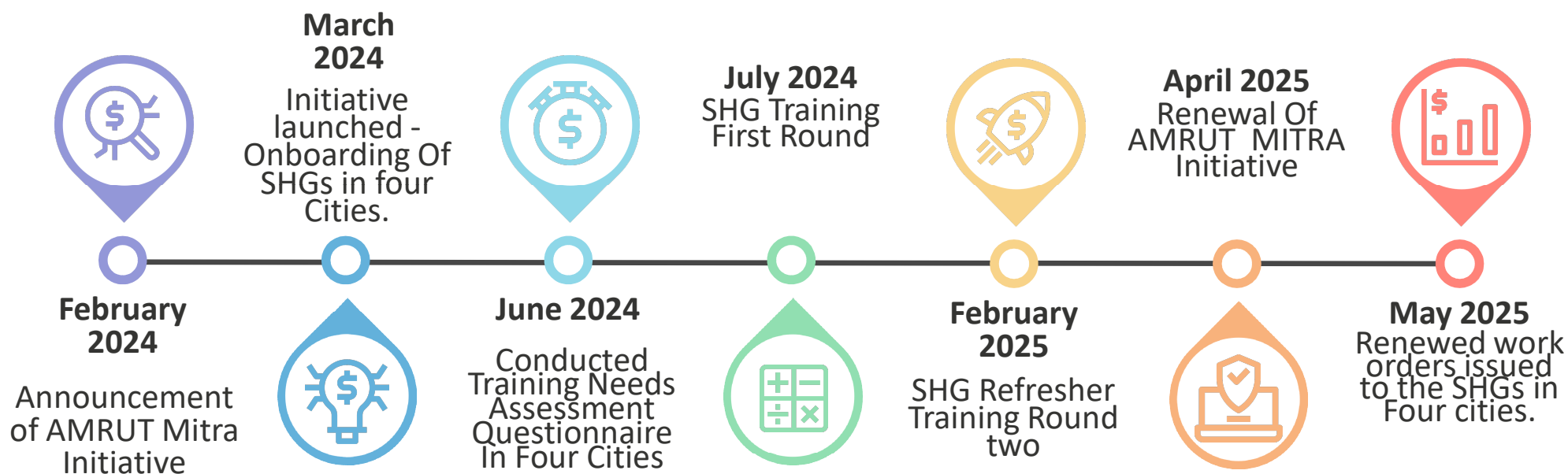

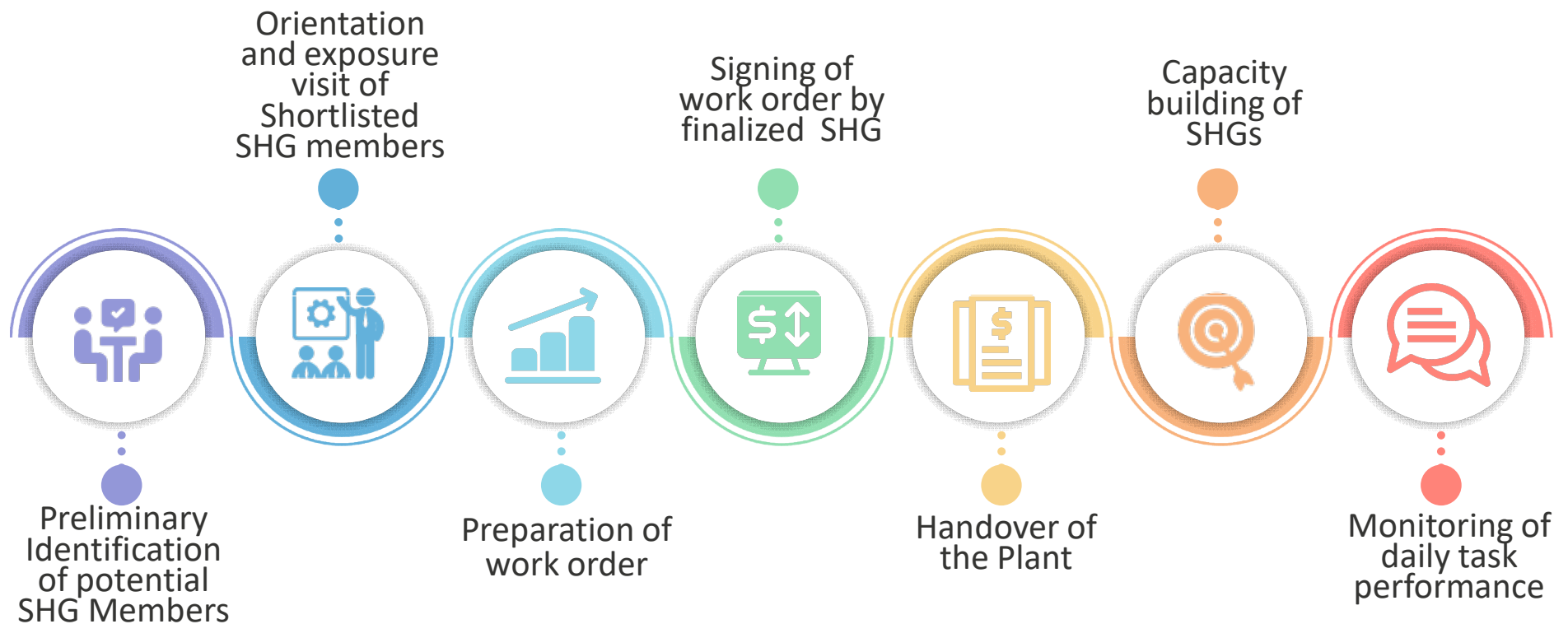

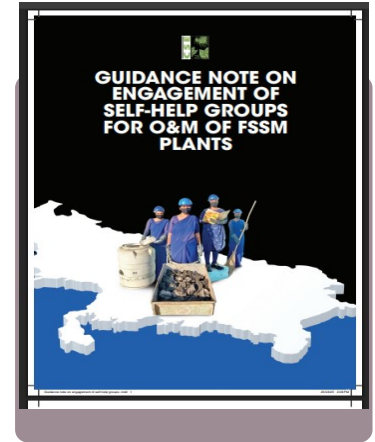

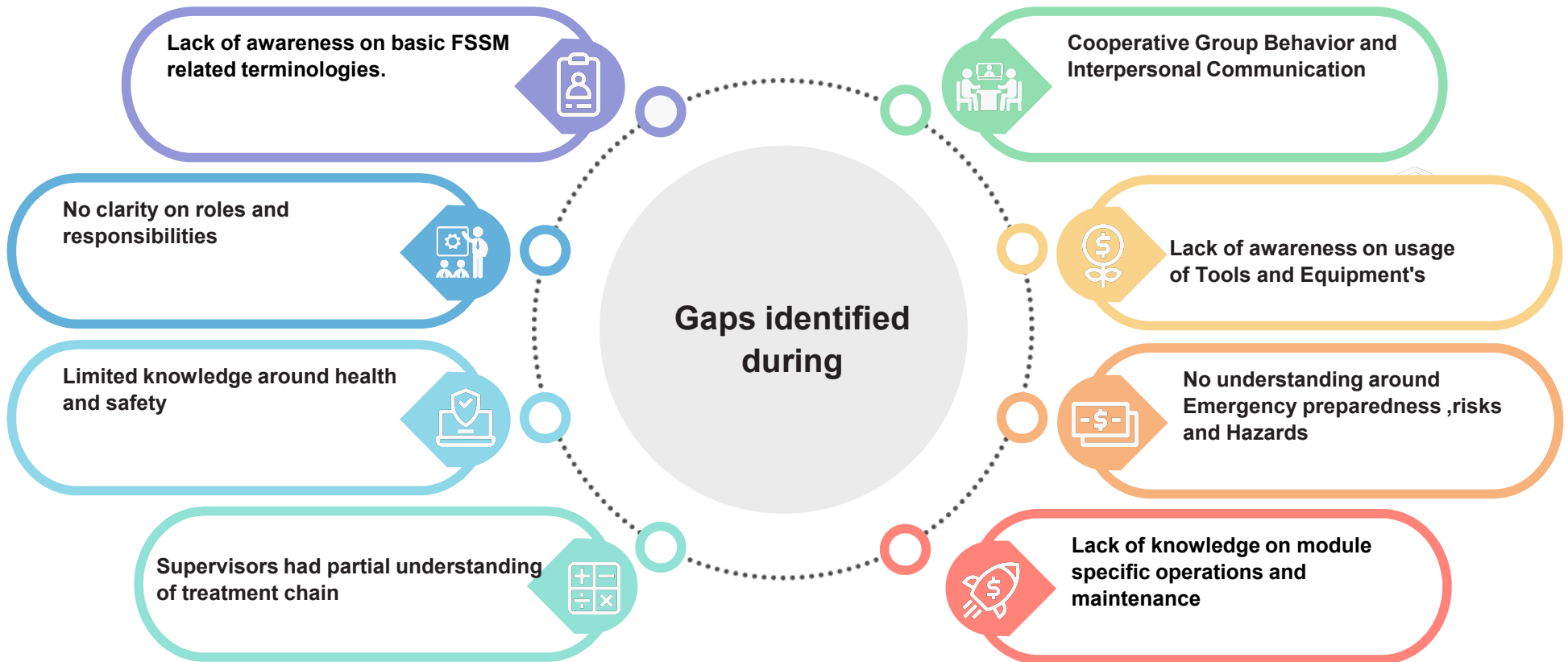

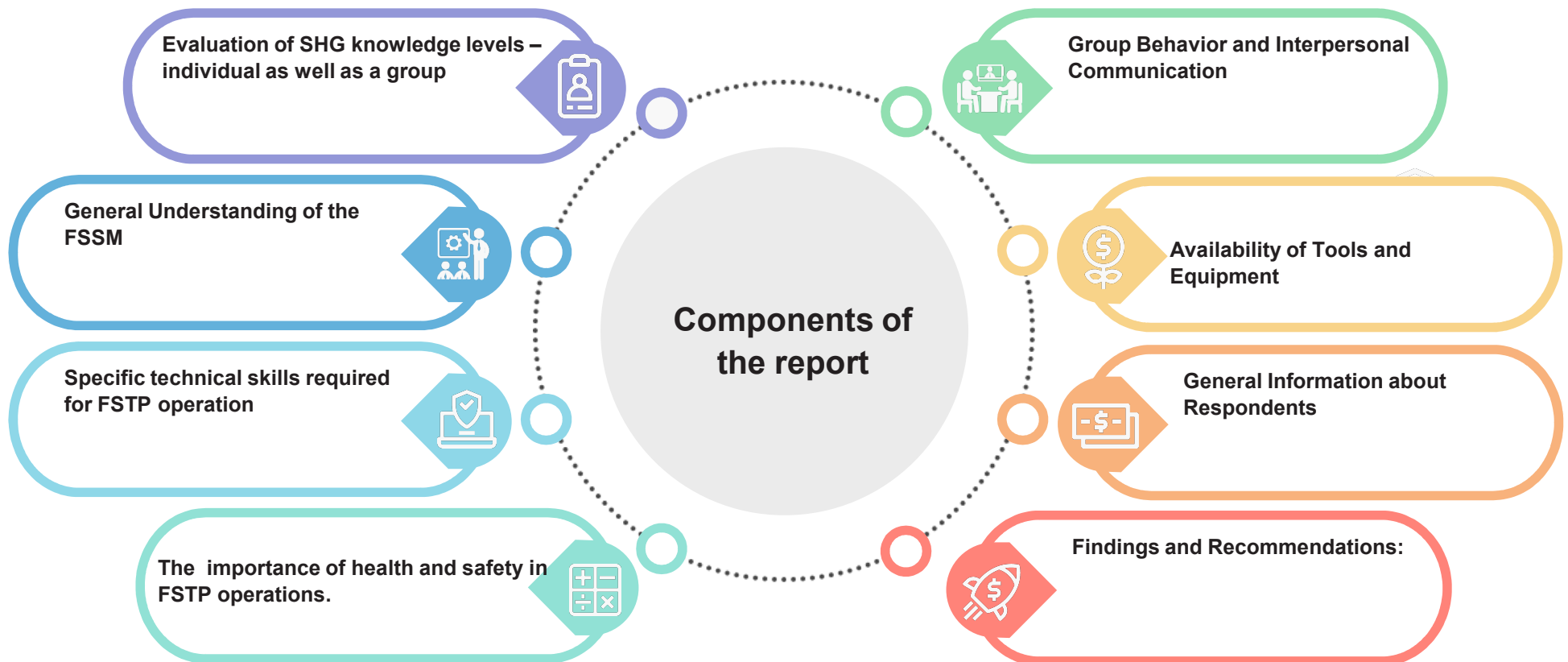

Components of Training need assessment report



Learnings from Training need assessment

1. Need to reinforce learning and keep SHG women updated on treatment modules and their functions
2. Ensure all FSTPs are equipped with first aid kits and safety equipment.
3. Ensure tools and equipment availability in cities
4. Development and Compliance to *Standard Operating Procedure (SOP) for Operations and Maintenance*
5. Regular monitoring and evaluation of daily tasks performed required for Sustainability of FSTPs
6. Establish a system for periodic evaluations and feedback to assess training effectiveness.
7. Strengthen collaboration between SHG women, supervisors, and urban local bodies for better coordination and resource support.
