**CITY ULB NAME:
Greater Hyderabad Municipal Corporation**

Improvement in status of waste management since December, 2017

Segregation in percentage (%): 80%

✓ *Segregation started since December 2017 till date*

✓ *Number of wards where segregation is happening:*

80% households in each of 150 wards are practicing segregation.

- Door to door (DTD) collection
- Collection efficiency (in %): 100%
- Processing (recycling & treatment of wet/dry waste): 100%
- Disposal: How much percentage is being disposed?
12% of total waste i.e., 593 TPD.

Proceedings were issued by Commissioner GHMC on 28.05.2011, Forming Chief Enforcement Officers to prevent littering and finalising rates to be imposed as penalty for various types of littering.

- **Any state policy to ban plastic?**

Under Process

- **Any other important initiative/practices adopted by city to push for segregation:**

- 44 lakh twin Bins were distributed to 22 lakh Households for promoting Source Segregation
- Swachh DHOOTH (Swachh CRPs) were assigned with the task of educating each household regarding significance of segregation. A total of 2000 Swachh Dhooth were engaged throughout GHMC with each Swachh Dhooth responsible for educating 600 Households.
- GHMC has launched **Swachh Dhooth App** to encourage Source Segregation. An incentive of RS. 1 lakh each month will be awarded to one eligible house wife selected through lucky draw for practicing source segregation and uploading the pictures of the same through the app.

Currently GHMC in coordination with ITC – WoW is promoting Home Composting by educating people on What is Wet and Dry Waste and How to practice Wet Waste Composting. However, It needs to bring more of Behavioural Change among citizens to make them practice Segregation and Home Composting.

Major gaps and challenges of source segregation

There is no Act regarding source segregation designating enforcement rights for ULBs to impose penalties to the violators.
