

Key Points Discussed during the meeting / way forward:

- CSE welcomed all the members of the Chunar SBCLTF to the meeting. CSE briefly presented the work done in Chunar till date and updated the members about establishment of Technical Support Unit (TSU) in the city.
- The "Chunar Faecal Sludge, Septage & Wastewater Management Regulations, 2019" prepared by Centre for Science and Environment and Chunar Nagar Palika Parishad was presented in the meeting by CSE team. It was highlighted that this is a draft document and the comments / feedback given by the Hon. Chairperson & Executive Officer shall be solicited and incorporated before presenting the document to the Chunar Municipal Council.
- CSE highlighted that the proposed bye-laws, once implemented, will help in ensuring that regulations are in place for effective faecal sludge, septage and wastewater management.
- CSE team also updated the SBCLTF about the "Pilot Faecal Sludge and Septage Treatment Plant" to be established in Chunar:
 - A revised DPR has been prepared by CSE in line with the revised discharge norms laid by NGT, as asked by SMCG-UP
 - The project consists of 4 major components, out of which Chunar Nagar Palika Parishad will be responsible for 3 viz. IEC; GIS Surveys & MIS Preparation; and procurement & O&M of vacuum tanker. For the same, a communication is underway for SMCG-UP to release fund (~ ₹50 Lakh) to CNPP.
 - The pilot FSSTP has been sanctioned by National Mission for Clean Ganga and Ganga Pollution Prevention Unit, UP Jal Nigam Varanasi has been identified as the implementation body for FSSTP. The treatment plant is in the tendering stage and shall be finalized by 30 August 2019.
 - The proposed plant shall prove to be a 'high visibility high impact' model project, which can be promoted and replicated in areas where sewerage network is not available for pollution abatement.
- CSE submitted a Project Report prepared for carrying out trenching in Chunar for safe management of faecal sludge, as a temporary measure. The members were made aware as to how trenching can prevent the indiscriminate disposal of faecal sludge and other salient features of the project.
- The meeting ended with a pledge taken by all present, committing themselves for a Swachh Chunar Swasth Chunar.
