CSE - School of Water and Waste (SWW) in collaboration with Regional Centre for Urban and Environmental Studies - RCUES is offering this tailor made training on 'Decentralized Wastewater, Faecal Sludge and Septage Management' cum field exposure visit for selected cohort of alumni (see details in target participants and fellowships criteria) and selected individuals with prior knowledge of the subject.

This training focuses on providing practical and hands-on experience to design and implement decentralized wastewater, faecal sludge and septage management including field exposure visit to successfully running FSTP and DWWT project sites (in Delhi – NCR and Odisha) giving an opportunity for participants to interact with real implementers as well as beneficiaries.

AIM

Support ongoing efforts of cities in achieving citywide sanitation including water security.

TRAINING FEES

INR 26,400 (for single occupancy accommodation)

(Includes tuition fee, training material, external expert lectures and sessions, boarding and lodging, transport from New Delhi to AAETI and back)

EXPOSURE VISIT FEES

No exposure visit fee for Government nominated officials.

If any other participant is interested to attend field exposure visit, he/ she is supposed to pay herself/himself for the flights (to and fro to Odisha from Delhi) and lodging.

FELLOWSHIPS AVAILABLE

Full Fellowship includes travel, boarding & lodging costs and training kit & fees costs. Preference will be given to alumni and representatives of CSE partner institutions.

Part Fellowship doesn't include to & fro to Delhi travel (from your respective location) costs but covers full boarding & lodging costs and training kit & fees. Single occupancy accommodation at AAETI and group pick-up & drop for local travel from pre-defined locations in Delhi.

Female participants are encouraged to apply and given preference in full / part fellowships.

Pre-read material will be provided for all selected participants.
